ORDER

As per Government Order read as 1st paper above Government have approved the Request for Qualification (RFQ) prepared based on the standard document formulated by the Planning Commission, Government of India for selection of Concessionaire (Development cum-Operator) for the Vizhinjam International Deepwater Multipurpose Seaport. Accordingly, Vizhinjam International Seaport Limited issued Global Tender Notices in leading Newspapers. Pursuant to it five firms/ consortia have submitted the Request for Qualification for the Development of Vizhinjam International Deepwater Multipurpose Seaport, which was opened by the Bid Opening Committee, constituted by the State Government.

The Empowered Committee discussed the Report on the Review of Request for Qualification Applications received from Financial Consultant & Transaction Advisor and Legal Advisor on the shortlisting of Applicants for the Development of the Project based on the Final Request for Qualification issued and decided to recommend the approval of the 5 shortlisted applicants to Government. As per the recommendation of the Empowered Committee and the request of the Managing Director, Vizhinjam International Seaport Limited, Government vide G.O read as 2nd paper above approved the shortlisting of 5 applicants who have submitted Request for Qualification for the development of Vizhinjam International Deepwater Multipurpose Seaport Project.

The Managing Director, Vizhinjam International Seaport Limited in his letter read as 3rd paper above reported that the 'Request For Proposal' document

is to be issued to the shortlisted applicants. The Empowered Committee in its 16th meeting held on 12-03-2014 discussed the Draft Request For Proposal in detail and decided to recommend to the Government of Kerala to approve the Draft Request For Proposal prepared and submitted by Vizhinjam International Seaport Limited based on the standard document formulated by Planning Commission, Government of India and to issue the same to the shortlisted Applicants, after the same is vetted by the Financial Consultant & Transaction Advisor and Legal Consultant.

Accordingly, Vizhinjam International Seaport Limited forwarded the draft 'Request For Proposal' to the Project Consultants for vetting and submitted the vetted Request For Proposal and certificates of vetting by Project Consultant to Government. Managing Director, Vizhinjam International Seaport Limited in his letter read as 3rd paper above requested Government to approve the vetted 'Request For Proposal' and to authorize Vizhinjam International Seaport Limited to issue the same to shortlisted applicants on behalf of Government of Kerala.

Government have examined the matter in detail and are pleased to approve the 'Request For Proposal' document in respect of Vizhinjam International Deepwater Multipurpose Seaport Project. Government also authorize the Vizhinjam International Seaport Limited to issue the same to the shortlisted applicants on behalf of Government of Kerala.
