

**NOTICE INVITING TENDER FOR HIRING VEHICLE ON CONTRACT ON MONTHLY RENTAL BASIS:**

The tenderer/s shall quote separate rate for each vehicle. Hence, separate EMDs and separate tender documents are required. The tenders in the specified form shall be submitted to the Managing Director, Vizhinjam International Seaport Ltd, 9th Floor, KSRTC Bus Terminal Complex, Thampanoor, Thiruvananthapuram-695001 in a sealed envelope (Cover III) superscribing as “Tender for Hiring Vehicle – Toyota Innova Crysta -I”/ “Tender for Hiring Vehicle – Toyota Innova Crysta -II” / “Tender for Hiring Vehicle – Sedan - Maruti Suzuki Dzire/ Honda Amaze”. The envelope shall contain two separate covers marked as Cover 1 -‘Pre-Qualifying bid’ and Cover II-‘Financial Bid’. Tender submitted without cost of tender form and the prescribed EMD will be summarily rejected. The exemption from payment of tender fee and EMD shall be only for the vehicles registered in the name of the MSME units.

VISL reserves the right to change the qualifying criteria at their discretion and the right to either accept or reject any or all of the tenders without assigning any reasons.
