**ORDER**

As per the Government Order read as 1st paper above Government had accepted the tender submitted by M/s. Deloitte Touche Thohmatsu Private Limited for preparation of Strategic road map, Organization structure and Systems for constitution of a State Maritime Board in the State at their quoted rate of Rs. 10.87 lakhs (Rupees Ten lakhs and Eighty Seven thousand only) with the implementation support of Rs. 17,000/- (Rupees Seventeen thousand only) per man days during the first year of implementation subject to the condition that the consultant should complete the consultancy work within three months.

2. Sanction was also accorded for meeting the expenditure regarding the consultancy fee to be paid to the M/s. Deloitte Touche Thohmatsu Private Limited from the Head of Account "3051-02-001-94 Formation of Maritime Board", vide Government order read 2nd above.

3. The Director of Ports vide paper read as 3rd above has reported the Government that an amount of Rs. 7,19,376/- (Rupees Seven Lakh

Nineteen Thousand Three Hundred and Seventy Six Only) (including Service Tax) has been paid to the firm and a balance amount of Rs. 4,34,800/- (Rupees Four lakhs thirty four thousand and eight hundred only) plus Service Tax has to be paid to the firm. In the current financial year (2012-13) budget provision the development of Maritime Board is included under the Head of Account "3051-02-001-90 Modernisation of Governance in Port Department".

4. In the circumstances the Director of Ports has requested Government to accord Revised Administrative Sanction for the payment of the balance amount of Rs. 4,34,800/- plus Service Tax to the firm as consultancy fee.

5. Government have examined the proposal in detail and are pleased to accord Revised Administrative Sanction for payment of the balance amount of Rs. 4, 34,800/- (Rupees four lakh thirty four thousand and eight hundred only) plus Service Tax to M/s. Deloitte Touche Thohmatsu Private Limited as consultancy fee for preparation of Strategic road map, Organization structure, Action Plan, Systems etc for constitution of a State Maritime Board in the state by debiting the expenditure under the Head of Account "3051-02-001-90 Modernisation of Governance in Port Department".
