In the circumstances reported by the Managing Director, Kerala Water Authority in the letters read above, Government are pleased to convey their approval to the Managing Director, Kerala Water Authority under the provision to clause IV of Sub Section (2) of Section 15 of the Kerala Water Supply and Sewerage Act 1986 for entering into an agreement with M/s. Chicago Constructions, Thiruvananthapuram (L2. Second Lowest tenderer) for the work of Design, Construction and Commissioning of Well-cum Pump house at Vellayani lake, raw water 200mm DI K9 pumping main, 3.3 mld capacity Water Treatment Plant, 1.33 LL capacity sump and pump house, OHSR 1.4 LL capacity and laying 250mm PVC gravity main etc. under the Water Supply Scheme to Vizhinjam Transshipment Terminal at the rate of lowest tenderer (L1) i.e., 42.85% above 2009 SoR and 15.62% above 2010 SoR for a quoted PAC of Rs.5,48,15,000/- (Rupees Five crore forty eight lakh and fifteen thousand only) excluding road restoration charges.
